# **FUN CLUB MEMBERSHIP BY-LAWS**

1. **THIS MEMBERSHIP APPLICATION AND CARDHOLDER AGREEMENT** between the above named members and Tan Tar A State Road LLC will be effective from the date of acceptance by the Membership Committee. This proposal is submitted with the knowledge that the number of members in the Clubs is restricted by the Board of Directors. The membership fee, in full, shall accompany this application, made payable to Tan Tar A State Road LLC. The Board shall not discriminate in the selection of members on the basis of race, color, creed, age, sex or national origin.
2. Members may bring guests only if the guests adhere to the rules, policies, and fees of the Fitness Center.
3. The Board of Directors of the Fitness Center shall have absolute authority regarding:
  - a. The determination of all activities, events, and other affairs at the Fitness Center
  - b. The determination of membership fees and dues from time to time.
  - c. The establishment from time to time for Rules and Regulations for the Fitness Center.
4. The Board shall act in the capacity of the Membership /Committee and have the exclusive authority of admitting members. It shall also be the function of the Membership Committee to investigate any and all violations of the Rules and Regulations or any other conduct which may result in the termination of membership
5. Hearing-Any member may be considered for termination by the Board of Directors or by the General Manager of Tan Tar A State Road LLC. The decision of the Board to terminate a membership shall be final and conclusive, subject only to reinstatement by the General Manager.

If membership is terminated by the Board, the member shall receive a pro-rated refund on his membership fee for the remainder of the term of the Agreement less any unpaid charges or damages. Grounds for termination include, but are not limited to: failure to pay membership or guest fees; failure to abide by Club rules; failure to establish credit or failure to pay for charges within 30 days of receipt of statement; disruption of club activities and bringing the club into disrepute; and engaging in dangerous activities.

6. The Member agrees not to use the Club facilities until he/she has had a physical examination by and received clearance from a competent medical authority. The Member assumes full responsibility for obtaining proper medical clearance and does not rely on the Resort, or its employees in any way in this regard.
7. The Member releases, on his behalf and on behalf of his heirs and assigns, its affiliated entities, employees and agents from all liability for any death, damage, loss of property arising out of Member's and his guest's use of the Club facilities. Member agrees to indemnify and save harmless Tan Tar A State Road LLC., from all liability for injury to third persons resulting from Member's or his guests' use of the Club facilities.
8. The Board of Directors may raise the membership fees at any time it deems necessary and at its own discretion.
9. Members are responsible for the dress and conduct of themselves and their family and guests at all times.
10. Membership Card is considered your pass and must be presented for use of all facilities at all times.
11. Membership Cards are non-transferable. Use of membership cards by anyone other than the person the card was issued to, will result in the card being surrendered upon demand and possible forfeiture of all Club privileges.

# **CLUB RULES AND REGULATIONS**

## **FITNESS CENTER AND POOLS**

1. Members shall be responsible for their dress and conduct.
2. Membership cards will be issued. Cards must be presented for admittance to the Fitness Center, Pools, and Indoor Waterpark (additional fees apply).
3. Only food and beverage items purchased on the resort are permitted. Coolers are prohibited.
4. Membership cards must be presented for charging privileges.
5. Tennis shoes and appropriate clothing required when working out at the Fitness Center.
6. Children must be accompanied by an adult while swimming at all pools. **NO LIFEGUARD ON DUTY.**
7. Must be 16 years of age to use the exercise equipment.
8. All posted rules are applicable.
9. Sun tan bed sessions are not included in the price of the membership.
10. Membership cards may be used only by the person whose name appears on the card. If used by someone other than the member, cards will be confiscated and the membership may be terminated without refund.

## **GOLF CLUB MEMBERSHIP**

1. In order to facilitate play, golf carts are mandatory at all times. The driver of the golf cart must be 16 years of age or older and must have in possession a valid driver's license.
2. Members may bring guests to the Golf Club, and these guests will be charged the Member/Guest rate for the green fees and cart fees.
3. The Golf Management has the right to close the golf courses at any time due to weather conditions or tournaments.
4. Members must maintain the appropriate speed of play on any given day.
5. The following dress code must be adhered to:  
GENTLEMEN: Sleeved shirts must be worn at all times. Dress shorts are permitted, excluding cut-offs and athletic shorts.  
LADIES: Sleeveless tops are permitted, excluding halter tops and bathing suit tops. Slacks and dress shorts are permitted.  
Appropriate shoes, such as golf or tennis shoes, are required at all times. No bare feet or street shoes are permitted.
6. All posted club rules are applicable.
7. Membership card must be presented for charging privileges and identification.
8. Membership cards are not transferable to other individuals.
